Call to Order

Jason Wren, President, called the meeting to order at 8:45 a.m. with notice of the meeting duly posted and a quorum present.

 Administer Oath of Office and Statement of Appointed Officials to at-large DEDC Board Member Jason Wren and City Councilman Jake Hayes

Barbara Metcalf, Notary Public, administered the Oath of Office and Statement of Appointed Officials to reappointed Board Member, Jason Wren, and City Councilman, Jake Hayes. After both were sworn in, they signed the Oath of Office and Statement of Appointed Officials.

Jason Wren called for approval of the May 17, 2023 Regular Meeting minutes and May 2023 bills. There were no changes or corrections. Mayor Mike McQuiston made the motion to approve the May 17, 2023 and the May Bills as presented, seconded by Jake Hayes and the consent agenda was approved unanimously.

3. Presentation of financial reports/statements:

City Sales Tax and Financial Report update

Nate Mara gave the financial reports and presented them as follows:

Nate Mara also gave an update on current and upcoming City projects and developments, taxable property values and new construction, and reported that the City is in the process of working on the FY 2023-24 Budget. Decatur continues to grow at a steady pace, and the City needs to plan to accommodate it. This concluded the financial reports.

4. Executive Director's Report on Economic Development

Kevin Holzbog began by making a gift presentation to the DEDC Board of Directors and City Staff to express his appreciation for all of the work they did to get the Bond 2023 in place for the purchase of the Landmark property.

Recruitment

- 1) Project DC4—the Landmark acquisition was needed for this project. The company is looking for a 4th distribution site and will require 30-35 acres for a 400,000 sq.ft. Facility. This project would create 50-75 full time jobs with a capital investment of \$55,000,000. A site visit is planned for September 2023. housing development and workforce availability is a key factor in the company's decision making for the new location, and they plan to make a decision by the end of Q3 of this year.
- 2) Project Playoff—this is a commodity level paint manufacturer that will be a \$35,000,000 capital investment
- 3) Project COLA—DEDC has recruited two individual Retailers that have made offers on 2 properties
- 4) Project C-Tac—DEDC is working with this Major Development Group

Business Retention and Expansion

1) GT Products--Cary Mellema will be giving and update on the progress of GT Products in Executive Session

Other

- 1) Workforce—There has been a meeting with DISD CTE Program, DEDC and Entegris, Inc. to consider reviving the Internship Program. The projected time frame is to have a good model program in place by FY 2024.
- 2) Landmark Property—Miss Jo's Rescue Ranch has found another location and will be vacating the property by September 2023. There was a Press Release in the Dallas Morning News regarding the purchase of the Landmark property which generated a lot of interest from potential clients to locate their business in Decatur. This was also posted on social media.
- 3) DEDC Website—the DEDC website is now complete and more current. DEDC has contracted with elMPACT as a data resource and they provide all the most current data for Decatur under a new tab "Local Data" on our website.

5. Marketing Report

Kevin Holzbog gave a short Marketing Report. Emily Smith, Marketing Coordinator, is at a Marketing Conference. Kevin Holzbog reported that Facebook has gained 145 more followers and Instagram has gained 70. The engagement rate for all of our social media pages is between 3-4, which is a very strong engagement rate.

6. Review and discuss proposed budget for FY 2023-24

Kevin Holzbog gave an overview of the proposed DEDC Budget for FY 2023-24. The DEDC Budget aligns itself with the City Budget and is proposing a conservative estimate of a 5% increase. The DEDC Reserve Fund has more than doubled over the last few years, and it is currently at \$5,906,000. We would like to get it to about \$10,000,000 in order to be competitive with larger cities for projects. The Operational cost has been reduced in order to balance the budget with the new Debt Service that has been incurred. The total proposed FY 2023-24 Budget it \$2,800,000. The FY 2023-24 Budget will be an action item on the July Board Agenda.
